Honesty and fairness

- The party involved has acted and will continue to act at all times honestly and fairly.
- He has not acted, and will not act, dishonestly, to cause loss to any party or deprive any party of its rights. Bribery and improper advantage
- The party involved has not offered or given and will not offer or give, immediately or indirectly, any bribe or other improper benefit or advantage to any person or organization.
- Has not requested or accepted and will not request or accept, directly or indirectly, any bribe or other improper benefit or advantage to himself or any person or organization.
- It has not carried out and will not carry out, directly or indirectly, any payment, unless such payment is legitimate compensation for lawful services.
- Has not received, and will not receive, directly or indirectly, any payment, except if the payment concerns a fee for the provision of legal services.

Misinformation

- Has not provided to any party and will not provide to any party any written or oral information which it knows to be false, inaccurate or misleading.
- Has not been intentionally hidden (as non-existent) from any party and will not withhold from any party any written or oral information.

Consent

• Has not authorized or participated in or concealed and will not authorize or not participate in or conceal any corruption incidents.

Conflict of interests

• Neither himself, nor any of the principal shareholders, senior officers or directors executives with whom it relates has disclosed no actual or potential conflict interests. It will immediately reveal any future actual or potential conflict of interests.

Acting impartially

- Has acted and will act impartially in executing any duty which requires him to act impartially, including below:
- Evaluation of offers.
- Certification of payments, extensions of time, variations or value or quality of works, services or materials.

Defective work

- In connection with the provision of works, materials, equipment or services, will not willfully, with willful blindness or negligence, perform, authorize, approve or be a party to:
- Provision of works, materials, equipment or services that do not comply with the contractual quality and quantity.
- Concealing defective work, materials, equipment or services.
- Payment for non-existent or defective work, materials, equipment or services.

Claims

- He will make only those claims which he honestly believes to be true and which can reasonably be supported by accurate written or oral evidence and to which he believes he has bona fide legal or contractual rights.
- As a party receiving allegations will not dispute or ignore such allegations and will promptly pay amounts, grant any extensions of time, issue certificates or take other steps that it honestly believes are relevant to disposing of the allegation.

Anti-corruption measures

• Will comply with anti-corruption measures applicable to the project.

Sanctions for corruption

- It will introduce and enforce contractual sanctions for corruption in relation to its business partners, officers and employees.
- Is aware of the fact that corruption can lead to criminal liability for both Companies and individuals and that the penalties for such liability can be severe and may include individual imprisonment and fines.

Limitation of Commitments

• It will obtain the above contractual commitments from each of its major subcontractors, agents and related companies and will take reasonable steps to enforce those commitments.
